

SUGGESTIONS AND RECOMMENDATIONS BY THE GENERAL BODY

4. Subsequently, after detailed deliberations on various issues the General Body collectively suggested the following measures and actions for improving the functioning of the college.
5. In the autonomous syllabus for B. Tech II year I Semester it was opined that the two subjects viz. MEFA and Technology Management were inappropriate for the II year but they would be more suitable for either third or fourth year students.
6. Foreign Language: Governing Body expressed its appreciation for including foreign language courses like French and German in the autonomous curriculum. However Governing Body advised that 'Chinese' Language i.e., Mandarin may also be considered for inclusion in the syllabus in view of the growing importance of this language.
7. Placements: Governing Body has conveyed its appreciation to the college for its achievement of about 60% placement record for the academic year 2015-16. In this regard, Sri K. Suryanarayana, TCS has offered to extend his kind help to facilitate the placement of Aeronautical Engineering students of MRCET.
8. Governing Body advised that college should encourage formation of student clubs in all the departments as these will play an important role in developing their soft skills which are very much required to get employment offers.
9. Governing Body recommended that there should be internal evaluation every year in the institution.
10. Governing Body suggested that value addition courses like Web design should be offered by the college. Dr.VSK Reddy clarified that college was already offering several value addition courses in the form of certified courses eg. Microsoft, CISCO, .net, Java and Business English Certification (BEC).
11. R&D: Governing Body suggested that a slide be prepared about the R&D projects granted to the institution and progress made there- in for apprising the general body.
12. Dr.VSK Reddy apprised the general body that college has applied for the renewal of NBA accreditation and that the NBA committee's visit to college is scheduled from 26-28 August 2016.

13. Prof. P. Sanjeeva Reddy thanked all the members for sparing their valuable time and offering valuable suggestions. He requested for their continued cooperation and support in future also.
