- b. The institution has already submitted Pre-qualifiers for B.Tech in Aeronautical Engineering, M.Tech in VLSI & Embedded Systems, M.Tech in Computer Science & Engineering and Masters in Business Administration (MBA).
- c. Pre-qualifiers of All above programs has been accepted by NBA and SAR online application is open for uploading and we are in the process of uploading SAR for the above programmes and it will be completed by February 20, 2020.
- d. The NAAC Accreditation is valid upto December'2020 and the institution is planning to submit renewal of NAAC accreditation application in December'2020.
