- 4. The program has been granted provisional accreditation. Malla Reddy College of Engineering & Technology, Maisammaguda, Dhulapally (Via), Hakimpet, Secunderabad- 500014, Telangana should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible to be considered by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a revisit, as deemed appropriate by NBA Committees.
