

TERMS & CONDITIONS

Acceptance of These Terms of Service

1. BY DOWNLOADING, INSTALLING, OR USING MRCET AUTONOMOUS APPS ("SERVICE", "MRCET AUTONOMOUS", "we", "us", "our"), YOU AGREE TO BE BOUND BY BOTH THESE TERMS OF SERVICE ("TOS") AND THE MRCET AUTONOMOUS PRIVACY POLICY. YOU CAN CHECK THE MODIFIED VERSION FROM THE SOFTWARE OR THE OFFICIAL WEBSITE. The award of the arbitration tribunal shall be final and binding upon the two parties.
